DEED OF PUBLIC TRAIL EASEMENT

Jeremy Ranch Owner's Association, a Utah non-profit Corporation ("Grantor") does hereby convey and warrant to the Snyderville Basin Special Recreation District ("The District"), a local Special District of the State of Utah, ("Grantee") for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, perpetual non-exclusive surface easements ("Easements") and rights-of-way for the purpose of constructing, operating and maintaining public trails and appurtenances within the Easements and rights-of-way granted herein over, across and through the Grantor's property situated in Summit County, Utah which are more specifically described in Attachment "A". This Deed is delivered by the Grantor as successor in interest to the Developer described in the Consent Agreement for the Jeremy Ranch Development recorded in the Office of the Summit County Recorder as Entry # 389144 ("Consent Agreement"), in compliance with and to implement the Easements and Public Trail dedication obligations of the Developer defined in the Consent Agreement, but only with respect to the Developer's obligations to dedicate or provide the Public Trail and Easements for Trails required by the Consent Agreement and for no other purpose.

The Grantor, its successors and its assigns hereby warrant the peaceful enjoyment of the Easements to the grantee and covenant that the Grantor shall not hinder, disturb, or damage the Grantee's improvements or prevent the use of the Easements by the Grantee.

The Easement shall cease and terminate if the use for which the Easements is granted is formally discontinued, permanently abandoned in fact, or becomes impossible, or the Easements are devoted to a different and inconsistent use, in which case the Easement shall revert to the Grantor, its successors and assigns after reasonable notice to the Grantee and after the Grantee fails to cure the cause of the proposed reversion.

The Easements shall only be used for non-motorized public recreation, except Grantee may operate motorized vehicles within the Easement solely for the purpose of maintaining the trail within the Easement.


The Grantee shall minimize the adverse impact to the Easements corridor and the adjoining property(s) in construction and maintenance of the Easements and shall restore any impacted property to the condition in which it was found prior to construction and maintenance of the Easements excepting the area within the developed Easements.

The Easements granted herein are subject to the condition that the Grantee shall indemnify and hold harmless, the Grantor, its heirs and successors against any and all liability caused by the acts of the Grantee, its contractors or agents, during the construction, operation or maintenance of the trails and use provided for in this easement. The Grantor's right to indemnification or to be held harmless by the Grantee under the terms of this paragraph is expressly conditioned upon Grantor giving written notice by mail, fax or email, to the Grantee within ten (10) days after Grantor has actual notice of any claim or demand which would cause a claim against the Grantee and upon the Grantees right to defend any claim against the Grantor which would cause a claim of indemnification against the Grantor. This provision shall not be

interpreted or construed to waive the rights of the Grantee to the affirmative defenses to claims provided under the Utah Governmental Immunity Act.

The Grantee shall reasonably control the introduction of noxious plants as defined by Summit County, Utah, within the Easements. If the Grantee fails to reasonably control noxious plants, The Grantor may perform the Grantee's control obligations and the Grantor shall be reimbursed by the Grantee.
